From the North/East: take US 2 & 41 west; turn right immediately after 41 Lumber on 17.4 Rd towards Wells Sports Complex. Go over railroad tracks; turn right on N.75 Dr.

From the South/West: take US 2 & 41 thru Escanaba to just past Gardens of Rest Cemetery, turn left on 17.4 Rd (41 Lumber on left side of Hwy) towards Wells Sports Complex. Go over railroad tracks; turn right on N.75 Drive.
